

## A quick guide to medical coverage for immigration pass holders

---

Effective **1st January 2026** and as per Department of Labour requirements, foreign nationals under selected categories of immigration passes are required to obtain a **medical plan when entering and while residing in Brunei Darussalam**.



### Who are the selected categories for this requirement?

---

#### 1<sup>st</sup> Phase Implementation (1st July 2025)

If you are:

- A. Entering Brunei for the purpose of:
  - I. Professional work/expertise (Professional Visit Pass)
  - II. Business (Business Visit Pass)
  - III. Visiting family / friends (Social Visit Pass)
  - IV. Tourist (Social Visit Pass)
  - V. Working as a domestic helper (Work Pass)
  
- B. Living in Brunei (Entry Permit) as a Permanent Resident under the category:
  - I. Foreign Nationals contributing to Brunei's Economy
  - II. Professionals

#### 2<sup>nd</sup> Phase Implementation (1st January 2026)

If you are:

- A. Entering Brunei for the purpose of:
  - I. Working under Private Sector (Work Pass)
  - II. Study (Student Pass)
  
- B. Living in Brunei (Dependent Pass) as:
  - I. A dependent (i.e spouse and children who are not attending school)



## What are my coverage requirements?

Each immigration pass category listed above has a different coverage requirement. Check the table below to see what's required by the Department of Labour and which plans are recommended for you.
